Due to unplanned maintenance on the Texas Eastern Pipeline system (TETCO), pressures have been reduced to a level that will not allow receipts into the Dominion Energy Ohio (DEO) system. TETCO's critical notice is available to view at the end of this posting. Consequently, effective Wednesday, June 10, 2020 (gas day 10) Timely Cycle until further notice, nominations from Texas Eastern Pipeline into DEO at the Clarington receipt point (Meter # 74040) must be reduced to 0 dt.

DEO will be monitoring the situation and will advise of any changes as soon as possible.

Subject: 30" Unplanned Outage - Fleming County, KY - Update 6 & PHMSA Amended Corrective Action Order

Notice Text:

Texas Eastern (TE) is providing the following update on its 30-inch pipeline system between its Kosciusko and Uniontown compressor stations.

PHMSA Amended Corrective Action Order (ACAO):

On June 1, 2020, TE received an ACAO from the Pipeline and Hazardous Materials Safety Administration (PHMSA) for Lines 10, 15 and 25 from Kosciusko to Uniontown. TE is currently reviewing the ACAO and is analyzing the operational impacts. As operational impacts are determined, TE will post the appropriate capacities along its 30" System and the estimated date when these capacities will go into effect. Based on initial review, TE anticipates capacity impacts for flows:

- 1) Southbound from Holbrook through Kosciusko
- 2) Eastbound and Northbound through Uniontown

Additionally, TE anticipates that point operators will experience lower than normal operating pressures on TE's 30" system from Kosciusko to Uniontown while TE addresses the stipulations of the ACAO. Delivery point operators may experience operating pressures up to 20% lower than historical values. As further details are determined, TE will post that information to its EBB as soon as it is known.

Current Capacity & Owingsville to Wheelersburg ("Impacted Area") Status:

As previously posted, TE has three lines between its Owingsville and Wheelersburg compressor stations that make up its 30-inch pipeline system in this area. These lines are: Line 10, Line 15 and Line 25. The May 4th incident occurred on Line 10.

At this time, Line 25 has been returned to partial service and TETLP is accepting nominations of 700,000 dth/d through Owingsville. Customers should continue to monitor TE's Operationally Available Capacity postings for the most up to date capacities.

Construction and work activities to comply with the ACAO associated with returning Line 10 and Line 15 back into service in the impacted area are on-going. TE will post further updates regarding Line 10, Line 15, and associated work regarding the ACAO as more information is known regarding a return to service plan. These pipelines will not be returned to service until we satisfy regulatory requirements and it is safe to do so. In addition, the NTSB and PHMSA are investigating the incident and TE is supporting that investigation. Due to this, we are unable to provide further updates on the investigation or the response.
